  - vii. How is the DO helping in the area of special education programs?
  - **viii.** What incentives are given to students at the secondary level that are getting good grades?
  - ix. A librarian, nurse and counselor full time are needed at Monroe.
  - **x.** New administrators need to shadow experienced principals.
