1. Call to Order

8. Review and Approve PAC Bylaws

- a. Suggested changes:
- b. Under “Membership” include MaderaTEC program as a voting member making it four middle schools. Also, the number of high schools should be changed to three high schools to include Matilda Torres.
- c. In “Term of membership” change the serving term to “up to two years.” Remove, “d. Committee members who were part of the initiation of the PAC may serve up to 3-year term with only up to 12 members before reappointed” as it no longer applies
- d. A parent asked if we could have a two-year term limit to Executive PAC positions so that a parent can be secretary for two years and if they would like to run for president and are elected, they can be president for two years. Babatunde clarified that right now we elect a person every year.
- e. A group of parents believes that the position should be as is in bylaws and be left open, allowing people to run and get voted for it. The main concern for term limits is that in the past few parents have volunteered to be part of Executive PAC because of the responsibility it entails and they encourage parents to run for a position for PAC.
- f. Another parent agrees that Executive PAC is a lot of responsibility, but also feels that parents can get an appreciation for the whole PAC membership means when they play those roles. She also believes that it is hard for others to run because those who have been running for a while may have more experience and be doing great work.
- g. Babatunde thanked all committee members for participating and leadership's time as well because there are many other meetings behind the scenes, and it is a significant time commitment. When we get to a place for more parent engagement and there is a lot of demand, that is when it makes sense to have a term limit, but from a district point, we need to have a functioning board to meet the state requirements that the state has for PAC. At this point, no term limit was included in the bylaws.
- h. A vote was taken to make the suggested changes and Sarah Machado motioned to approve changes and Shawn Prim seconds the motion.
