III. Gang Task Force Collaborative: Lawrence Fernandez

- Heavy gang activity in our middle schools and three High Schools
- MUSD is collaborating with MPD, Probation, Distinct Attorney, MCSOS, Madera Behavioral Health to meet bi-monthly and bring our resources together ro reduce gang activity.
- Creating opportunities for our students/families to develop capacity around gangs and encouraging our students to select positive outlets
- The focus of the task force is: Prevention, Intervention and Enforcement
- Building a list of students that are playing a key role in gang activity (Bubble Youth)
- Reaching out directly to the students and completing home visits to also educate parents
- Gang workshops have been arranged for parents this semester in collaboration with our Gang Consultant Hector Garibay. These workshops are done in both English and Spanish.

IV. School Resource Officers: Lawrence Fernandez

- Thank you to the support the MUSD School Resource Officers provided over the past several years.
- This year's data shows that our SRO's are more vital than ever, handling a growing number of incidents and ensuring our schools remain a safe place for all.
- SRO's not only respond to immediate needs but also build relationships with students, making themselves approachable and trusted figures on campus.
- Story shared regarding personable examples of the SRO's impact with students on campuses.

V. Cell Phone Initiative for Middle Schools/Ripperdan: Prince Marshall & Lawrence Fernandez

- Hosted two town halls (in-person and virtual) explaining to the community the current law and direction of the district regarding cell phone YONDR pouch.
- Discussed the schools we visited and they're experiences
- Impact of cell phones on our youth academically, behavior, mental health and less school day interruption with school threats.
- The program will start January 2025 for the Junior High Schools and High School will begin August 2025.
- A FAQ brochure needs to be created for staff, students and parents.

VI. School Hoax responses: Lawrence Fernandez

- Across the state and nation schools are dealing with an increase in social media hoaxes.
- We take these calls very seriously every single time.
- Our district has had approximately ten since the school year started.
- Many of the calls came through the week of September 16, 2024.
- MPD was informed that an extremist group was taking requests to make threats to schools starting on October 3, 2024.
- If it can be traced to someone specific, the suspect runs the risk of pending criminal charges
