2. The site maps that wee provided do not specify seal coating on new asphalt, but in the specs, it say seal coat of all asphalt surfaces. Please confirm that the new asphalt receives seal coat or not. **Do not seal coat new asphalt**

3.In the spec it refers to Bus Lanes: replacement, removal of asphalt, but it does not mention the removal of the base. Is the 6" base existing or are we to remove the full 10" section and replace with 6" base and 4" HMA? **Only replacing 4" HMA**
