### **Elementary and Secondary EDI Coaching Report**

- Certificated non-represented management salaries portion of the \$65,325,044 is roughly \$1.4 million, or 1% of total expenditures. Trustee Cogdill responded that his figures show for 52 of the top administrators equals \$4,270,000 and \$1.2 million for 15 job coaches. Mr. Porterfield asked Trustee Cogdill to have his list with him so he can go over it with Trustee Cogdill.
- o Mr. Porterfield then addressed Trustee Arredondo's question about the \$20million and outlined the difference between "actual" and "budgeted" expenses.
