NOTICE INVITING BIDS PURSUANT TO PUBLIC CONTRACT CODE 22000, ET SEQ.  
(THE UNIFORM PUBLIC CONSTRUCTION COST ACCOUNTING ACT)

Notice is hereby given that the Madera Unified School District (“MUSD”) will receive sealed bids for **Bid No.112922-Roof Restoration Projects at Multiple School Sites**  
**A Mandatory Job-Walk will be held December 06, 2022 @ 9:00 a.m. starting at:**  
**Eastin Arcola-29551 Avenue 8, Madera CA 93637, then to Madera HS-200 South L Street, Madera CA 93637, then to Lincoln Elementary School-650 Liberty Lane, Madera A 93637**

To the extent required by Public Contract Code Section 20103.7, the District shall also make the Contract Documents available for review at one or more plan rooms.

Pursuant to the provisions of Section 1770 et seq of the California Labor Code, each worker of the contractor and any of its subcontractors engaged in work on the Project shall be paid not less than the prevailing wage rate.

SB 854 established new public works contractor registration program requirements for all public works projects. Pursuant to Labor Code Section 1725.5; Starting March 1<sup>st</sup>, 2015 no contractor/subcontractor may be listed in a bid proposal unless registered with the Department of Industrial Relations (DIR). Starting April 1<sup>st</sup>, 2015 no contractor/subcontractor may be awarded a contract, nor employed on a Public Works project unless registered with the DIR. This project is subject to prevailing wage requirements and compliance monitoring and enforcement by the DIR and may at any time require contractors/subcontractors to upload electronic certified payroll records on the DIR website.

Bidders shall be required to have a valid class “C-39” Contractor’s License.

**Sealed Bids must be received by December 13, 2022 by 10:00:00 am at MUSD Purchasing Department, 1205 Madera Avenue, Madera CA 93637. (located on the 2<sup>nd</sup> floor)**

**This Bid contains two(2) Bid Sections, Bid Section A and Bid Section B. This Bid will be awarded to the lowest bidder per Bid Section.**

The Estimated Cost for the projects are as follows:

Bid Section A-Eastin Arcola and MHS - \$177,000.00

Bid Section B-Lincoln Elementary School-\$370,000.00

Bids shall be accompanied by a certified check, cashier’s check or bidders bond in an amount not less than ten (10%) percent of the total bids made payable to MUSD.

The substitution of appropriate securities in lieu of retention amounts from progress payments in accordance with public Contract Code Section 22300 is permitted.
