Service Provider Requirements:

- 1. Service Provider must provide a valid SPIN at the time the bid is submitted, and the SPIN must be included in the response documentation.
- 2. Service Providers must have a current FCC Red Light Display System Status of Green.
- 3. Service Providers must demonstrate a minimum of 5 years of experience in K-12 education or city/county government markets.
- 4. Service Providers must demonstrate a minimum of 5 years of E-Rate Category 1 Internet Access or WAN experience.
- 5. The Service Provider is able to begin providing services by July 1, 2025.
- 6. The **Madera Unified School District** may elect either the Billed Entity Reimbursement or Service Provider method of invoicing.
- 7. All components and associated labor not eligible for E-rate funding must be provided in a separate quote.
- 8. All ineligibles and all ineligible allocations on eligible must be clearly included in your proposal.
- 9. Vendors must contact the technical person listed by e-mail for any questions, bids, and or proposals. For our protection, the consultant does not talk with vendors by phone. Technical questions will be answered only by the technical contact person listed.

Project and Contract Requirements

This project is dependent on partial funding from the E-rate program. All contracts entered into as a result of the posting of the Form 470/RFP will be contingent upon the approval of discounts from the Universal Services Administrative Company (USAC) and Madera Unified School District acceptance of the funding award. No part of this contract will be valid or executed outside of E-Rate timelines and approvals unless authorized by the Madera Unified School District.

- a. Estimated Discount is 90% for the Madera Unified School District.
- b. All proposals must show broken down costs individually for each site, if multiple sites are seeking service.
- c. Ineligible items and features must be clearly included in your proposal.
- d. Any non-recurring costs must be submitted separately with cost explanation (i.e., Installation, Initial Configuration, Equipment).
- e. All pricing must include taxes, shipping/handling, and all other eligible fees.
- f. Prices must be held firm for the duration of the contract or until all work associated with the project(s) are complete (including any Universal Services Administrative Company (USAC) approved extensions).
- g. Any implementation that is done prior to the funding award must be requested and approved in writing by **Madera Unified School District**.
- h. Services covered by this contract cannot take place before the contract start date of July 1, 2025 unless requested by **Madera Unified School District.**
- i. Growth Clause requested as part of contract terms. Growth services may or may not be requested by **Madera Unified School District** during the contract term. **Madera Unified School District** may increase bandwidth during the term of the agreement to any of the speeds quoted without any change in contract terms other than the price.
- j. All vendors must comply with **Madera Unified School District** Local, State, and Federal contracting requirements including but not limited to:
 - · Prevailing Wage
 - · Insurance
- k. Notice To Proceed:
 - This project is contingent on funding from the E-rate program. As such, the Madera Unified School District will not issue a Notice to Proceed until a copy of the approved Funding Commitment Decision Letter (FCDL) has been received from USAC and a Form 486 "Receipt of Service Conformation" has been filed. Contractor will not be permitted to commence work, unless otherwise directed by Madera Unified School District until a Notice to Proceed has been issued. The Madera Unified School District will not be responsible for costs incurred by the Service Provider prior to receiving a Notice to Proceed.
- 1. Reservation of Rights:
 - a. **Madera Unified School District** reserves the right to award all, none, or select portions of this bid to one or multiple Service Providers. **Madera Unified School District** reserves the right to negotiate terms and conditions of the RFP as necessary, to reject any or all proposals, to increase quantities, and to waive any irregularities or informalities in the RFP or in this process.

Bids Disqualification Criteria and Madera Unified School District Needs:

- 1.All "SPAM" and/or "Robotic" responses will not be considered valid bids and will be disqualified.
- 2. Only bids that supply a complete solution will be evaluated, and partial bids will be disqualified.
- 3. All bids that don't include the requested services, term of services will be disqualified.
- 4. Only one bid will be awarded for the Project.

Proposal Evaluation:

It is anticipated that a contract will be made with the provider whose proposal is determined to be the most cost effective and in the overall best interest of **Madera Unified School District**. The main evaluation considerations are: 1) Price, 2) Prior Experience 3) Understanding of Needs 4) Compatibility with existing infrastructure, and 5) Completeness of Response.
