NOTICE INVITING BIDS PURSUANT TO PUBLIC CONTRACT CODE 22000, ET SEQ. (THE UNIFORM PUBLIC CONSTRUCTION COST ACCOUNTING ACT)

Notice is hereby given that the Madera Unified School District ("MUSD") will receive sealed bids for Bid No.040720-Asphalt Resurface & Repair Projects at Various School Sites

A Mandatory Job-Walk will be held April 28, 2020 @ 9:00 a.m. starting at Parkwood 1150 E. Pecan Madera Ca 93637 (meet at front office),proceed to Madison Elementary 109 Stadium Rd, Madera High School 00 South "L" Street, Adams Elementary 1822 National Ave, MLK 601 Lilly St and ending at LaVina 8594 Road 23, Madera Ca 93637 All Bidders must sign in at each location.

Pursuant to the provisions of Section 1770 et seq of the California Labor Code, each worker of the contractor and any of its subcontractors engaged in work on the Project shall be paid not less than the prevailing wage rate.

SB 854 established new public works contractor registration program requirements for all public works projects. Pursuant to Labor Code Section 1725.5; Starting March 1st, 2015 no contractor/subcontractor may be listed in a bid proposal unless registered with the Department of Industrial Relations (DIR). Starting April 1st, 2015 no contractor/subcontractor may be awarded a contract, nor employed on a Public Works project unless registered with the DIR. This project <u>is</u> subject to prevailing wage requirements and compliance monitoring and enforcement by the DIR and may at any time require contractors/subcontractors to upload electronic certified payroll records on the DIR website.

Bidders shall be required to have a valid class "A" or "C-12" Contractors License

Sealed Bids must be received by May 6, 2020 no later than 10:01 am located at MUSD Purchasing Department, 1205 Madera Avenue, Madera CA 93637.

Bids shall be accompanied by a certified check, cashier's check, or bidders bond in an amount not less than ten (10%) percent of the total bids made payable to MUSD.

The substitution of appropriate securities in lieu of retention amounts from progress payments in accordance with public Contract Code Section 22300 is permitted.

Due to the current and changing situation and to continue with work that is needed at our School Sites we have implemented changes as to how we are going to handle the Bid Turn In Process.

The District encourages vendors to submit bids in advance by mail and we will accept emailed bid packets.

If you email the packet, it will only be accepted if it is sent to susanharautuneian@maderausd.org and it must be received no later than the date and time listed.

In order to comply with CDC guidelines and applicable Government requirements, no public opening will take place. Instead, MUSD staff will open all bids and a recap will be posted on the District website by end of day.

Once the Bid is Awarded,

the Awarded bidder will be required to submit all the original copies to the Purchasing Department.
