NOTICE INVITING BIDS PURSUANT TO PUBLIC CONTRACT CODE 22000, ET SEQ. (THE UNIFORM PUBLIC CONSTRUCTION COST ACCOUNTING ACT)

Notice is hereby given that the Madera Unified School District ("MUSD") will receive sealed bids for **Bid No. 040924-New UTK Buildings at Lincoln Elementary School**

A mandatory Job-Walk will be held April 17, 2024 @ 9:00 a.m. Lincoln Elementary School -650 Liberty Lane, Madera CA 93637 (meet at front office)

To the extent required by Public Contract Code Section 20103.7, the District shall also make the Contract Documents available for review at one or more plan rooms.

Pursuant to the provisions of Section 1770 et seq of the California Labor Code, each worker of the contractor and any of its subcontractors engaged in work on the Project shall be paid not less than the prevailing wage rate.

SB 854 established new public works contractor registration program requirements for all public works projects. Pursuant to Labor Code Section 1725.5; Starting March 1st, 2015 no contractor/subcontractor may be listed in a bid proposal unless registered with the Department of Industrial Relations (DIR). Starting April 1st, 2015 no contractor/subcontractor may be awarded a contract, nor employed on a Public Works project unless registered with the DIR. This project <u>is</u> subject to prevailing wage requirements and compliance monitoring and enforcement by the DIR and may at any time require contractors/subcontractors to upload electronic certified payroll records on the DIR website.

Bidders shall be required to have a valid class "B" Contractor's License.

All general contractors and all mechanical, electrical, plumbing, and fire sprinkler subcontractors will be required to pre-qualify to bid on this project. A copy of the prequalification applications may be downloaded from Madera Unified School District Purchasing Department Website <u>https://www.madera.k12.ca.us/Page/6984</u>. Please check the MUSD purchasing website to confirm the sub-contractors that are already pre-qualified with MUSD.

Prequalification applications are due by Monday, May 6, 2024 @ 10:00:00 a.m.

An updated list of prequalified subcontractors will be posted to the MUSD website on Thursday, May 9, 2024.

Sealed Bids must be received by May 14, 2024 at MUSD Purchasing Department, 1205 Madera Avenue, Madera CA 93637. (located on the 2nd floor) no later than 10:00:00 a.m.

The Estimated Cost for this project is \$2,800,000

The District has allotted 385 calendar days for the project from the date of the Notice to Proceed. The District anticipates construction starting approximately **June 10, 2024.** This project includes a milestone for the relocation of two existing portables. The two portables shall be complete and ready for occupancy on **July 26, 2024.** Liquidated damages will apply to this milestone.

Bids shall be accompanied by a certified check, cashier's check , or bidders bond in an amount not less than ten (10%) percent of the total bids made payable to MUSD. The substitution of appropriate securities in lieu of retention amounts from progress payments in accordance with public Contract Code Section 22300 is permitted.
